## Terms and Conditions for Private Instrumental Lessons at St Martin's

- **1.** Private tuition during school hours is available in piano, guitar, drum kit, flute, recorder, singing and violin.
- 2. Contact tutors directly to book a lesson. If there is no vacancy, you may request to go on the tutor's waitlist.
- 3. An individual lesson **fee starts from \$25 for 20 minutes** or \$37 for 30 minutes. Students may elect to do a maximum of TWO instruments at school.
- 4. Lesson fees must be paid directly to your tutor in accordance with their terms and conditions.
- 5. This private tuition contract is engaged between you and the tutor. Failure to comply with the terms and conditions may mean lesson termination and any monetary disputes resolved legally in court.
- 6. Students must **complete at least ONE TERM** of study. Four week's

<u>written notice</u> must be given should a student wish to discontinue lessons through the school. Letters must be emailed to both the instrumental tutor and the school music coordinator.

7. Students are expected to catch up on all class work they have missed whilst at an instrumental lesson.

## 8. **ABSENCES**:

Please inform <u>your tutor</u> **latest by 8am lesson day** *of unexpected absences*. For planned family events, sport or school excursions it is preferable that tutors are informed in advance before the term so it can be reflected in your invoice.

- 9. **Missed lessons** <u>will be charged</u> unless you have given your tutor enough notice.
- 10. If a tutor is absent, the tutor will contact students and the school office **prior to 8am** on the day and organise make-up lessons or **credit** fees into the following term.
